2018 Rule Changes:

Rule 3 Page 51: Calf Roping/Over 40
Change time limit from 60 seconds to 30 seconds.

Rule Change: Barrier judge will also watch the timed event run and assist the flag judge with calls. Such as crossfires, catches, dog falls, day lighting the calf. Take care of neck ropes, both have to agree for the call to be valid.

Rule Change: Team roping barrier shall never exceed 12 foot without the director's approval. If the roping arena is less than 200ft long the barrier will be shortened 6 inches for every 20 feet, not to exceed 10 foot.

Rule Change: Page 59 Rule 1 Remove 1" in length and replace it with half the ear length."

Rule Change: Rough Stock Events – BB, SB, BR It will be determined by the stock contractor is the rough stock riders would like to enter twice. Clarifications will be added to the rule book:

- It is up to the stock contractor what events will enter twice.
- This must be designated in the rodeo approval form
- Both rides would count towards the standings
- If contestant is injured on the first ride, they will not be reimbursed their entry fees from the second entry.
